## Leave an Environmental Legacy to Future Generations

Through Wildlife Media, there are many ways to make a lasting contribution to wildlife and our planet's wildest places. They include a financial commitment to Wildlife Media via your will, living trust, and other investments. Because estate planning can be complex, it is important that your attorney and/or financial advisor help structure your estate plans to ensure your charitable gifts meet your personal and financial goals. The following information will help guide you when working with your advisor(s).

## **Giving Through Your Will or Trust**

You can remember Wildlife Media in your will or living trust through three different kinds of bequests:

**Specific Bequest:** This type of bequest allows you to leave a stated sum of money or percentage of your estate, usually in the form of a cash distribution. To make a specific bequest, have your attorney review and include the following wording in your will:

"I give, devise, and bequeath to Wildlife Media, a Washington state nonprofit corporation located at 1208 Bay St., Ste. 202, Bellingham WA 98225, tax identification number 20-8802794, the sum of \$ (insert amount or percentage here) to be used for its general purposes."

**Residuary Bequest:** This type of bequest allows you to leave a remainder or a percentage of the remainder of your estate once all specific bequests have been satisfied. Have your attorney review and use this wording to leave a residuary bequest:

"I give, devise, and bequeath to Wildlife Media, a Washington state nonprofit corporation located at 1208 Bay St., Ste. 202, Bellingham WA 98225, tax identification number 20-8802794, all (or insert percentage here) of the rest, residue, and remainder of my estate to be used for its general purposes."

**Contingency Bequest:** This type of bequest allows you to make your gift contingent on other circumstances. It is important to name a contingent beneficiary to receive assets in case your named beneficiaries do not survive you. To leave a contingency bequest, have your attorney review and include this paragraph:

"If any of the above-named beneficiaries should predecease me, I hereby bequeath his or her share to Wildlife Media, a Washington state nonprofit corporation located at 1208 Bay St., Ste. 202, Bellingham WA 98225, tax identification number 20-8802794, to be used for its general purposes."

To reduce or avoid estate or inheritance taxes on your gift, have your attorney review and include the following language in your will:

"I direct that no estate or inheritance tax be paid from the share of any property devised or bequeathed to Wildlife Media."

If you already have a will, you can use the suggested wording to make a codicil (short legal note) that names Wildlife Media as a beneficiary of your estate. Your attorney can help you do this.

## Giving Through Your Life Insurance Policy

You can name Wildlife Media as a direct beneficiary of all or part of your life insurance policy, or as a contingent beneficiary. You would still own the policy.

- You can donate your paid-up life insurance policy directly to Wildlife Media.
- If you have a new or non-paid-up policy, you can name Wildlife Media as both the owner and beneficiary of this policy. You would still be responsible for paying the premiums.

You should discuss the tax benefits of a life insurance donation with your attorney or other financial advisor. Different estate-tax savings apply depending on whether Wildlife Media is the beneficiary of a policy, owner, or named as a new owner of a policy.

## **Giving Through Your Retirement Plan**

Retirement plans (including 401(k), 403(b), SEP, or other retirement plans with tax-sheltered investments) may incur considerable taxation to your estate and your heirs. So a gift of some or all of these assets may be the most tax-wise way of leaving a legacy. You can name Wildlife Media as a direct or contingent beneficiary of a stated percentage or the entire amount of your retirement plan.
